Acceptance of the Software and Protocol by your institution confirms your agreement to the following conditions:

1. This Agreement and the resulting transfer of the Software and Protocol constitute a nonexclusive license to use the Software and Protocol for non-profit, non-clinical, academic research purposes only. The Software and Protocol will not be used for diagnostic purposes in humans and will not be used for any commercial purpose. For the purpose of this agreement, commercial purposes shall include, but not be limited to, (a) providing sequence tags developed through the use of Software and Protocols to a company, (b) providing any information developed using Software or Protocol to a company or (c) using the Software or Protocols in corporate sponsored research or for consulting purposes. This agreement is not assignable and the Software and Protocol may not be transferred to another party.
2. You are free to modify the Software and Protocol; however, any such modifications shall be considered Software and Protocol under the terms of this Agreement and shall be the property of JHU. You understand that JHU has filed patent applications and owns copyrights related to the Software and Protocol. You are free to make a limited number of copies of the Software and Protocol for the purpose of backup and maintenance of the Software and Protocol provided that any such copies carry the copyright notice of JHU.
3. You are free to publish your work involving the Software and Protocol. You agree to provide JHU with a copy of any publication which contains results obtained from use of the Software and Protocol.
4. JHU makes no representations whatsoever as to the Software and Protocol. They are experimental in nature and are provided WITHOUT WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR ANY OTHER

WARRANTY, EXPRESS OR IMPLIED. JHU MAKES NO REPRESENTATION OR WARRANTY THAT THE USE OF THE SOFTWARE AND PROTOCOL WILL NOT INFRINGE ANY PATENT OR OTHER PROPRIETARY RIGHT.

5. Except where precluded by Federal law and to the extent allowed by State law, you and your institution agree to defend, indemnify, and hold harmless JHU, its trustees, officers, employees, and agents from any loss, claim, damage, or liability, of any kind whatsoever, which may arise from you or your institution's use, storage, or disposal of the Software and Protocol except to the extent such arise due to the gross negligence of JHU.

6. You shall not use the name of THE JOHNS HOPKINS UNIVERSITY or THE JOHNS HOPKINS HEALTH SYSTEM or any of its constituent parts, such as the Johns Hopkins Hospital or any contraction thereof or the name of its employees in any advertising, promotional, or fundraising documents without prior written consent from an officer of JHU.
